RENTAL AGREEMENT

- I accept full responsibility for the care of all rental equipment (the "Equipment") rented or used during Mission Ridge Winter Park's 2026-2027 season and I agree I am liable for any loss or damage to the Equipment. I agree all rentals are for a period of one day only and I must return the Equipment prior to the close of business on the day I rent the Equipment.
- I agree to return the Equipment in a clean, undamaged condition at the end of each rental period to avoid any additional charges. I further agree to pay Mission Ridge Winter Park for the full retail value of the Equipment if not returned by the end of each rental period or damaged beyond repair. I understand that I may be required to provide my credit card number as security for the Equipment and I hereby authorize Mission Ridge Winter Park to charge my credit card for any damage or loss.
- I am familiar with the proper use of the Equipment. I understand that the rental technicians are able to answer questions I may have as to the proper use of the Equipment.
- DOWNHILL SKI EQUIPMENT ONLY** I will provide the Equipment User's accurate height, weight, age, skier type and binding preference where required. This information is required in order to properly adjust the ski boot/binding settings. I agree to verify that the settings appearing in the visual indicator windows on the bindings correspond with the settings provided by Mission Ridge Winter Park. I acknowledge that Mission Ridge Winter Park will be relying on the information provided by me to provide the Equipment for the duration of Mission Ridge Winter Park's 2026-2027 season. I agree that if any of the Equipment User's height, weight, age, skier type, or binding preference changes during Mission Ridge Winter Park's 2026-2027 season, I will immediately inform Mission Ridge Winter Park prior to receiving the Equipment.
- I acknowledge that this Release Agreement shall apply to all Equipment rentals and participation in skiing and snowboarding during Mission Ridge Winter Park's 2026-2027 season.

ASSUMPTION OF RISKS

I am aware that participating in skiing and snowboarding will expose me to many risks, dangers and hazards that could result in physical injury, psychological injury, paralysis, brain injury, death, property damage or loss, including loss to other third parties. I am aware that injuries are a common and ordinary occurrence in these activities. I understand these risks, dangers and hazards include but are not limited to: equipment failure; improperly adjusted equipment; boarding, riding and disembarking ski lifts and conveyors, including falls therefrom and misloads; exposed rocks, earth, ice and other natural objects; trees, tree wells, tree stumps and forest deadfall; collisions with lift towers, fences, snowmaking equipment, snow grooming equipment, snowmobiles, or other equipment, vehicles, structures or objects; collisions with or being struck by other persons; loss of balance or control; use of terrain parks; slips, trips and falls; poor or limited visibility; negligence, inattention or experience of other persons; and **NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES IN RESPECT OF: (I) THE DESIGN, MANUFACTURE, INSTALLATION, MAINTENANCE, SELECTION OR ADJUSTMENT OF THE EQUIPMENT, (II)THE PROVISION OF OR THE FAILURE TO PROVIDE ANY WARNINGS, DIRECTIONS OR INSTRUCTIONS AS TO THE USE OF THE EQUIPMENT, OR (III) THE FAILURE TO WARN ME OF OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF SKIING OR SNOWBOARDING.**

ALPINE SKIING I understand that the ski boot/binding system may not release during every fall or may release unexpectedly. The ski boot/binding system is no guarantee that the Equipment User will not be injured.

SNOWBOARDING I understand that the boot/binding system is not designed or intended to release and will not release under normal circumstances. I understand that as the boot/binding system is a non-release system, this system will not reduce the risk of injury during a fall and will increase the risk of not surviving an avalanche.

HELMETS I understand that a helmet designed for snow sports activities may reduce the risk of some types of head injuries at slower speeds. I recognize that serious head injury or death can result from both low and high energy impacts, even when a helmet is worn.

I AM AWARE OF, FREELY ACCEPT AND FULLY ASSUME ALL OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH SKIING AND SNOWBOARDING AND WITH THE USE OF THE EQUIPMENT, AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE, OR LOSS RESULTING THEREFROM. I FURTHER AGREE THAT MY PARTICIPATION IN SKIING AND SNOWBOARDING AND MY USE OF THE EQUIPMENT IS PURELY VOLUNTARY AND I ELECT TO PARTICIPATE DESPITE THESE RISKS, DANGERS AND HAZARDS.

In consideration of the rental and use of the Equipment and participation in skiing and snowboarding, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury, including death, that I may suffer, or that my heirs, next of kin, executors, administrators, assigns and representatives may suffer, resulting from or arising out of any aspect of my use of the Equipment or participation in skiing and snowboarding, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES IN RESPECT OF: (I) THE DESIGN, MANUFACTURE, INSTALLATION, MAINTENANCE, SELECTION OR ADJUSTMENT OF THE EQUIPMENT, (II)THE PROVISION OF OR THE FAILURE TO PROVIDE ANY WARNINGS, DIRECTIONS OR INSTRUCTIONS AS TO THE USE OF THE EQUIPMENT, OR (III) THE FAILURE TO WARN ME OF OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF SKIING OR SNOWBOARDING

2. TO HOLD HARMLESS, INDEMNIFY AND DEFEND THE RELEASEES from any and all liability for any property damage, loss, or personal injury to any third party resulting from my use of the Equipment and my skiing and snowboarding;

3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity;

4. This Release Agreement and any rights, duties, and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of Saskatchewan and no other jurisdiction;

5. Any litigation involving the parties to this Release Agreement shall be brought solely within Saskatchewan and shall be within the exclusive jurisdiction of the Courts of Saskatchewan;

6. If this Release Agreement is completed electronically, I consent to signing this Release Agreement electronically and confirm that my electronic signature is the legal equivalent of my manual signature in this Release Agreement; and

7. If any provision of this Release Agreement is held by a Court to be unenforceable, then such provision will be modified to the minimum extent necessary to make it enforceable while reflecting the Participant and Releasees' intention as closely as possible. All remaining provisions of this Release Agreement shall remain in full force and effect as drafted.

In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of skiing or snowboarding or the use of the Equipment other than what is set forth in this Release Agreement.

I CONFIRM THAT I HAVE READ AND I AGREE TO THIS RELEASE AGREEMENT. I AM AWARE THAT, BY SIGNING THIS RELEASE AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES, INCLUDING THE RIGHT TO SUE. I ACKNOWLEDGE THAT I AM SIGNING THIS RELEASE AGREEMENT FREELY AND VOLUNTARILY AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
